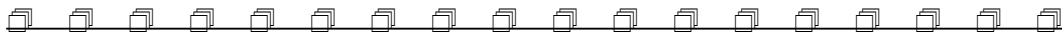

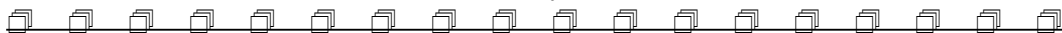
They never saw the man or his assistant again, only lots and lots of monkeys!

2. **Thinking right, December 2008, Dr. Vance Lackore**

As we attempt to evaluate the fallout of the election of Barak Obama to the Presidency and consider the end of 2008, what will we face in 2009 and beyond? One major difference is that we elect the President and Vice President, thanks to the wisdom of our Founding Fathers.

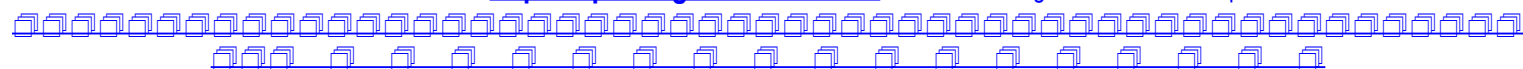
President Bush, as a Candidate in 2000, when asked who was asked the historical figure he most admired
